# Strengthening Civil Society Organization in Anuradhapura and N Eliya District

ADRA Sri Lanka is part of a global network present in over 118 countries around the world and has been operating in Sri Lanka since 1983. At present, ADRA is a registered and a well-known International NGO in Sri Lanka and is operating under 4 key sectors including Water, Sanitation and Hygiene (WASH), Refugee Reintegration and Economic Development, Emergency Response, and Health and Nutrition.

Throughout the years ADRA has partnered with various stakeholders including government and private institutions, donors, and communities, and has implemented various projects to empower and uplift lives of countless people throughout Sri Lanka.

Targeting vulnerable groups in Anuradhapura and Nuwara Eliya Districts, the project will support District-level CSOs (D CSOs) and Grassroot-level Community-Based Organizations to implement interventions and empower communities. Through capacity building and advocacy, the project seeks to create a sustainable network of change agents, promoting food security and well-being for over 500,000 individuals. Key themes include gender mainstreaming, social inclusion, local ownership, and green recovery, aiming to improve the livelihoods of women, youth, and children in Sri Lanka.
