ORGANIZATION

The Adventist Development and Relief Agency (ADRA) Sri Lanka is a locally registered NGO that has been operating in Sri Lanka since 1982. We are also part of the global ADRA network, which is active in 118 countries worldwide. Our primary focus areas include WASH, Nutrition, Refugee Reintegration, Economic Development, and Youth Development.

THE PROJECT

The CSO INTERCEDE project aligns and focuses on enabling Civil Society Organizations (CSOs) to support vulnerable groups in coping with the socio-economic crisis in estate and rural Sri Lanka. The action aims to strengthen CSOs' skills and capacity to improve the nutritional status of women, youth, and children, engage in policy dialogue on nutrition and livelihood, and advocate for enhanced nutritional status and viable livelihoods. By partnering with CSOs, the project will empower local communities to address nutrition and livelihood needs and navigate the impacts of the crisis. Targeting vulnerable groups in Anuradhapura and Nuwara Eliya Districts, the project will support District-level CSOs (D CSOs) and Grama Niladhari-level Civil Society Organizations (GNCSOs) to implement interventions and empower communities. Through capacity building and advocacy, the project seeks to create a sustainable network of change agents, promoting food security and well-being for over 500,000 individuals. Key themes include gender mainstreaming, social inclusion, local ownership, and green recovery, aiming to improve the livelihoods of women, youth, and children in Sri Lanka.

THE OBJECTIVE OF THE ASSIGNMENT

The overall objective of this consultancy is to map the current food supply system in Anuradhapura and Nuwara Eliya districts and provide actionable insights to improve food security, reduce post-harvest losses, and promote equitable access to nutritious food. This exercise will involve identifying and assessing local food producers within the target communities, aiming to understand the strengths and weaknesses of the existing food supply systems.

The consultancy will also focus on identifying local-level enterprises in the DS divisions where Project work, with the potential to contribute to the food supply system and strengthening their capacity to respond to future food crises. In addition, the consultant will provide business development training to livelihood beneficiaries, whome the project has been supporting under the Livelihood development activity, with the aim of enhancing their knowledge in areas such as financial management, business plan development, and other key aspects of enterprise growth. The following key objectives will be addressed through this assignment:







1. Mapping of available Local Food Supply System.

- To identify key stakeholders and actors involved in the local food supply chain and produce a desegregated directory of them (including farmers, transporters, processors, traders, retailers, etc.) within the DS division.
- To analyze the flow of major food commodities from production to consumption
- To assess the infrastructure, logistics, and institutional frameworks supporting the food supply
- To identify bottlenecks, risks, and opportunities for improving the efficiency and resilience of the system
- To provide strategic recommendations for strengthening the local food supply system
- To assess the current local food supply system in both districts, including key actors, logistical pathways, infrastructural strengths and gaps

2. Development of Food supply system Enhancment plan.

- To develop a comprehensive and actionable food supply system development plan aligned with national and local policy frameworks.
- To propose feasible short-, medium-, and long-term actions for local food system improvement within the division.

3. Dissemination and Stakeholder Engagement.

- To organize and facilitate dissemination sessions to present the Food System Enhancement Plan
- To gather feedback from key stakeholders and facilitate dialogue to refine and validate recommendations for future implementation

4. Conduct Business Resilience Trainings.

- To develop a training module to enhance the resilience of selected enterprenures
- To build the business management capacity of selected enterprises through practical and relevant business development training.
- To improve the ability of enterprises to anticipate, withstand, and adapt to disruptions through business resilience training.
- To support enterprises in developing business continuity plans and growth strategies.
- Conduct training programs for the enterprenure community (20 slelected enterprises)(financial management, marketing stratergies, product diversification) 6 sessions per district.

The consultant is required to conduct an assessment of selected enterprises within the Anuradhapura & Nuwara Eliya area that have the potential to contribute to the local food supply system. Based on the findings of this assessment, 20 enterprises should be selected for further support and training.	
08	Development of Training Modules	Consultant is expected to develop training modules. These modules need to cover topics such as financial management, marketing strategies, and product diversification with the objective of strengthening and making the local business resielient for national, global economic fluctuations. Six training sessions to be planned for each district.	







09	Facilitating the training sessions	Six training sessions will be conducted in each district. These trainings will be organised having one month interval in between each training.
10	Training report	A report is expected at the end of each training sessions, which will include the description of the module, methodology, feedback of participants, recommendation of monitoring stratergies, etc.

KEY TERMS AND CONDITIONS

The total value of the contract is LKR 625,000/- per district, which is the maximum amount that can be allocated from the project. When selecting a consultant, the lowest quoted price among the received quotations will be considered as one of the criteria in the evaluation and scoring process

- 1. Payment will be made according to ADRA's payment schedule 30% after signing the agreement, 30% after completing deliverables 1–6 in the scope of work, and 40% after submitting the final report, with payment made by demand draft or bank transfer upon providing account details
- 2. Withholding taxes of 5% will be deducted from all payments above 100,000 within the month. If the consultant submitting the current account is registered for a relevant consultancy service, withholding tax will not be deducted.
- 3. All Incidentals, accommodation, and travel required for the assignment are to be born by the consultants except where otherwise indicated in the consultancy agreement.
- 4. The consultant should follow CSO- INTERCEDE Visibility protocols and Branding policies and make sure ADRA and the European Union logos are presented as per the guidelines.
- 5. The consultant and all personnel involved in the implementation must comply with the child protection policy and other relevant ADRA policies.
- 6. CSO- INTERCEDE Project may request written evidence of necessary coverage provided by the consultant for their services.
- 7. All requirements in respect of insurance including professional indemnity, worker's compensation, public liability, superannuation, and taxation, where applicable will at all times remain the responsibility of the consultant.
