#### **ORGANIZATION**

The Adventist Development and Relief Agency (ADRA) Sri Lanka is a locally registered NGO that has been operating in Sri Lanka since 1982. We are also part of the global ADRA network, which is active in 118 countries worldwide. Our primary focus areas include WASH, Nutrition, Refugee Reintegration, Economic Development, and Youth Development

#### THE PROJECT

The CSO INTERCEDE project aligns and focuses on enabling Civil Society Organizations (CSOs) to support vulnerable groups in coping with the socio-economic crisis in estate and rural Sri Lanka. The action aims to strengthen CSOs' skills and capacity to improve the nutritional status of women, youth, and children, engage in policy dialogue on nutrition and livelihood, and advocate for enhanced nutritional status and viable livelihoods. By partnering with CSOs, the project will empower local communities to address nutrition and livelihood needs and navigate the impacts of the crisis. Targeting vulnerable groups in Anuradhapura (Palagala DS) and Nuwara Eliya (Norwood DS) Districts, the project will support District-level CSOs (D CSOs) and grassroots-level Based Organizations to implement interventions and empower communities. Through capacity building and advocacy, the project seeks to create a sustainable network of change agents, promoting food security and well-being for over 500,000 individuals. Key themes include gender mainstreaming, social inclusion, local ownership, and green recovery, aiming to improve the livelihoods of women, youth, and children in Sri Lanka.

#### THE ASSIGNMENT

The assignment is a video consultancy service to produce five high-quality, informative videos on relevant government policies, with a focus on CSO (Civil Society Organizations)-related and nutrition-related policies. The purpose is to create videos that clearly communicate these policies and make them available online for future use.







#### THE OBJECTIVE OF THE ASSIGNMENT

The objective of this consultancy is to develop high-quality, informative videos on relevant government policies, with a particular focus on CSO-related and nutrition-related policies, and to make these videos available online for future use.

The consultant will be responsible for producing videos that effectively communicate these policies. The project team will identify the key policies, messages, and stakeholders to be featured, based on a comprehensive understanding of the project's goals and target audience. The consultant is expected to collaborate closely with the project team to develop a content outline and determine the format, length, and style of each video.

Of these, in total six videos; in 03 in Tamil and 03 in Sinhala and all videos should include English subtitles. Video shooting will be conducted over one day at each project location, in the Norwood DS and Palagala DS areas. The consultant will be responsible for filming, editing, and producing the final videos in accordance with ADRA's policies and practices, ensuring that the content effectively communicates key messages and is suitable for the target audience.

The ADRA Communications & Public Relations Officer, along with the project team, will serve as the primary points of contact for the consultant. All videography should be conducted in accordance with ADRA's policies and practices.
